# THE ARTS ACCESS AND ADVOCACY SUPPORT

Involvement and enrichment through the arts inspires, engages and builds positive community—it should be more deeply engrained and supported in underserved Northeast Ohio communities.



### CRIMINAL JUSTICE EDUCATION, ADVOCACY AND SUPPORT

Advocacy and support for individuals and families navigating the criminal justice system should be available to all, especially to populations experiencing systemic racism in Northeast Ohio.



### ADOLESCENT YOUNG ADULT (AYA) CANCER SUPPORT

Access to innovative and population-specific cancer care should be available to all AYAs in Northeast Ohio in order to improve outcomes and quality of life for adolescents and young adults age 13-30.



# REPRODUCTIVE HEALTH EDUCATION AND SERVICES SUPPORT

Access to routine, quality and respectful reproductive health services should be available to all individuals of any age in Northeast Ohio.

# ENVIRONMENTAL ACTION, AWARENESS, AND ADVOCACY

Access to air and water that is free of pollution should be available across all zip codes in Northeast Ohio.
